INSTALLATION & INBETRIEBNAHME

Installation der Treiber

1. Legen Sie die mitgelieferte Software-CD in Ihr CD-ROM-Laufwerk ein.
2. Ziehen Sie die Schutzhülle vom WLAN-Dongle.
3. Stecken Sie den Dongle in einen freien USB-Port an Ihrem Computer oder Notebook.
4. Warten Sie, bis der Computer das Gerät automatisch erkannt hat. Unter Windows XP und Vista wird ein Treiber benötigt, der sich automatisch installiert.
5. Nach erfolgreicher Installation wird der Dongle im Windows-Gerätemanager als Netzwerkkarte mit dem Namen „Atheros AR9271 Wireless Network Adapter“ aufgelistet.
6. Das Gerät ist nun betriebsbereit.

Nach erfolgreicher Installation können Sie den WLAN-USB-Dongle verwenden. Über den Windows-Netzwerk-Manager können Sie sich mit dem gewünschten WLAN verbinden.



Installation der JumpStart-Software

2. Falls das Installationsprogramm nicht automatisch startet, doppelklicken Sie bitte die Datei „setup.exe“, um das Programm JumpStart zu installieren.
3. Folgen Sie den Anweisungen auf dem Bildschirm, um die Installation abzuschließen.

2. Wählen Sie den Punkt „Join a Wireless Network“ um sich mit einem WLAN-Netzwerk über WPS zu verbinden. Es stehen Ihnen dabei drei verschiedene Auswahlmöglichkeiten zur Verfügung:

3. Halten Sie die WPS-Taste des WLAN-Dongles für 3 bis 5 Sekunden gedrückt.


